GUIDANCE OF REGULATION AND BEHAVIOUR FOR ENTERING SARDINIA. USEFUL PROVISIONS TO HAVE YOUR SAFE HOLIDAY IN ALGHERO.

Before entering Sardinia WHAT TO DO?

For entering Sardinia following requirements are needed:

- In order to monitor arrivals and stays in Sardinia, all persons entering the island, whether at an airport or ferry port, regardless of their country of origin, are required to register themselves by using a self-certification form (modulo registrazione Sardegna) which has to be filled out and sent via the digital platform (https://www.regione.sardegna.it/) or via "Sardegna Sicura", a contact tracing application for iOS e Android systems to be downloaded on the app-store and whose use is on a voluntary basis.
- Every passenger must present
 - a) copy of the successful registration
 - b) boarding pass
 - c) valid identity card

Before boarding, the carrier's staff is required to check the self-certification

3. A mandatory body temperature screening is required for all travellers entering Sardinia. For boarding procedure, temperature must not be equal to or more than 37.5 C degrees.



For entering Sardinia it is required to fill out the self-certification form via the platform:

https://sus.regione.sardegna.it/sus/covid19/regimbarco/init?lang=en posted on this QR-Code: modulo registrazione Sardegna

All arriving passengers are obliged to fill the self-certification form in, to provide personal data, contact information (mobile phone), travel information and personal health conditions, so they can be contacted if they, or someone they may have been in contact with, develops the disease.

Particularly, the information to be given must include the number of an identity document. Travellers are also explicitly requested to notify their place of accommodation (hotels, camping, self-catering apartment, etc.).

The form includes also a series of questions regarding **possible symptoms compatible with Coronavirus** (e.g. whether within the latest 21 days you had fever, cough or experienced any breathing difficulties) and on close contacts with confirmed cases of Covid-19 disease.

RESPECT ALWAYS AND IN ANY CIRCUMSTANCE GUIDING PRINCIPLES AND BASIC HEALTH AND BEHAVIOURAL REGULATIONS.

Please stay up to date with the latest information on the spread of the pandemic, available on the WHO website and on the Italian Ministry of Health website.

THE FOLLOWING MEASURES ARE RECOMMENDED TO MINIMISE THE LIKELIHOOD OF TRANSMISSION OF COVID-19.

- Wash your hands often and thoroughly with hydroalcoholic solutions for washing hands available in all public places.
- Avoid hugs and handshakes
- 3. Maintain an interpersonal distance of at least 1 meter (about 3 feet), when in social contact. Interpersonal distancing does not apply to members of the same household or cohabiting group.
- 4. Respiratory hygiene (sneeze and/or cough in a disposable paper towel avoiding hand contact with any respiratory secretions). If paper tissues are not available, coughing or sneezing into the elbow bend is recommended.
- 5. Avoid communal use of bottles and glasses.
- 6 Do not touch your eyes, nose and mouth with unwashed hands.
- 7 Cover your mouth and nose if you sneeze or cough.
- **8.** Do not take antiviral drugs and antibiotics, unless prescribed by your doctor.
- 9. At first, clean surfaces with soap and water or regular mild detergents to remove dirt. Then sanitize all surfaces with sodium hypochlorite or alcohol solutions (bleach). Make sure the solutions are diluted properly.
- During any social contact, it is strongly recommended to use a respiratory tract protection, as an additional measure to other individual health and hygiene protection measures.
- 11. It is mandatory throughout the country to use respiratory protection in closed spaces that are accessible to the public, including means of transport, and in any case on all occasions when the maintenance of a safe distance cannot be quaranteed.
- 12. Children under six years of age, as well as people with disabilities that are not compatible with the continuous use of a mask, their carer and people interacting with them, are not subject to such obligation.
- 13. For screening purposes, body temperature can be measured and access denied to those with 37.5 C degrees temperature or above.

GUIDANCE OF BASIC RULES OF BEHAVIOUR WITHIN HOSPITALITY AND TOURIST FACILITIES.

- Maintain an interpersonal distance of at least 1 meter (about 3 feet), when in social contact. Interpersonal distancing does not apply to members of the same household or cohabiting group. Guests who are travelling together and sharing rooms need not be requested to maintain physical distance among themselves.
- For screening purposes, body temperature can be measured and access denied to those with 37.5 C degrees or above.
- 3. Airway protection masks must be used in all indoor spaces accessible to the public and whenever interpersonal distances cannot be ensured at all times, but in cases of the exceptions set out in current regulations (children under 6, those with disabilities incompatible with long term mask use and those interacting with these).
- 4. Hand hygiene should be practiced frequently, wash hands thoroughly. Being mandatory to sanitize hands on entering in all indoor spaces accessible to the public, use available dispensers with hydroalcoholic solutions for hand cleansing near the entrance and in areas of frequent transit and on exiting.
- 5. Access to facilities via booking is to be preferred.
- Displayed information on prevention measures set out by the responsible authorities must be followed.
- Electronic payment methods must be preferred.

Accommodation facilities

Guests are obliged to use masks in any time in indoor communal areas.

In communal outdoor spaces masks must be worn if interpersonal distances of at least 1 meter (about 3 feet) cannot be respected and staff must wear masks at all times when in proximity to clients and when interpersonal distances of at least 1 meter (about 3 feet) cannot be ensured.

Use of lifts must guarantee interpersonal distances to be respected, with masks, with exceptions applying in the case of family members, those cohabiting and people sharing rooms and as regards those to whom interpersonal distancing regulations do not apply.

Public Spaces

It is not necessary to wear a mask in public spaces unless the physical distancing of at least 1 meter (about 3 feet) cannot be observed.

Free Beaches

A distance among sun umbrellas (or other shade systems) must be guaranteed providing at least 10 square meters of space per umbrella.

A distance of at least 1.5 meters (about 5 feet) between beach facilities (sunbeds, deck chairs) must be ensured when these are not under umbrellas.

Amusement/sporting activities encouraging group formation are banned.

Individual sports frequent on beaches (such as beach tennis) or in the sea (e.g. swimming, surfing, windsurfing and kitesurfing) can continue as long as interpersonal distancing quidelines are complied with.

Bathing establishments

Amusement/sporting activities encouraging group formation are banned

Individual sports frequent on beaches (such as beach tennis) or in the sea (e.g. swimming, surfing, windsurfing and kitesurfing) can continue as long as interpersonal distancing quidelines are complied with.

Swimming Pools

All **personal clothing and objects** must be kept in personal bags even where these are stored in lockers. It is recommended to avoid shared use of the lockers, and bags should be made available for personal effects.

A distance of at least 1.5 meters (about 5 feet) between beach facilities (sunbeds, deck chairs) must be ensured among people not belonging to the same household.

Gym centres

Maintain an interpersonal distance of at least 1 meter (about 3 feet) when not performing physical exercise or at least 2 meters during physical exercise (with special attention to intense exercise).

Flasks, glasses and bottles should not be shared and objects such as towels, bath robes and other items should not be exchanged with other users.

Footwear exclusive to this purpose should be used at the gym.

All personal clothing and objects must be kept in personal bags even where these are stored in lockers. It is recommended to avoid shared use of the lockers, and bags should be made available for personal effects.

Hair stylists and beauticians

Where the specific service concerned allows, client and staff must wear airway protection masks where an interpersonal distance of less than 1 meter (about 3 feet) is required.

Do not read magazines and info material for multiple use.

Shops

Use of disposable gloves is recommended in purchasing activities, particularly for the purchase of food and beverages.

Shops and supermarkets may take their own action to avoid crowding. This can include monitoring the number of customers within the store and limiting access to avoid congestion.

Wear always a mask

Open air Markets and Craft Markets

Use of disposable gloves is recommended in purchasing activities, particularly for the purchase of food and beverages.

Use masks on all occasions when the maintenance of an interpersonal distance of at least 1 meter (about 3 feet) cannot be guaranteed.

Restaurants, Bars and Takeaway service

Clients must wear masks whenever they are not seated at tables.

Counter service is allowed only if an interpersonal distance of at least 1 metre between clients can be guaranteed, except for those not subject to interpersonal distancing based on current regulations.

Buffet service involving serving by staff is allowed as long as clients are prevented from touching the food and 1 metre distance between clients and between clients and staff can be respected and airway protection masks are used.

If you are collecting your food in person from a takeaway or restaurant which offers a pick-up service, you should adhere to the social distancing rules set out by the government and by the food business. This may include having staggered collection times and using a queue management system to maintain the 1 metre separation.

Museums, Archives and Libraries

Booking access online, through website or by calling is recommended.

Visitors must always wear a mask.

The use of lifts should be limited to those with reduced mobility where possible.

Cinemas and Theatres

The audience must always wear a mask.

Cinemas and outdoor Theatres

Respect guidelines.

Archaeological sites

Access to the sites via booking is recommended.

It is not necessary to wear a mask in open spaces unless the physical distancing of at least 1 meter (about 3 feet) cannot be observed.

The Neptun's Caves

Booking is recommended by calling the phone number +39 079 94 65 40.

According to the current rules on social distancing and avoiding public gatherings, visits will be limited to a significantly reduced number of people.
